

“Likkle Extra Brawta from Paymaster” – Promotion

Start Date: Monday 23rd January 2023

End Date: Tuesday 28th February 2023

The “**Likkle Extra Brawta from Paymaster**” Promotion (the “Promotion”) Frequently asked Questions (“FAQs”) and Terms and Conditions (the “Terms”) apply to you and govern your participation in the Promotion for a chance to win a cash prize of \$100,000. You should read these FAQs and Terms carefully before participating in the Promotion.

“We” or “us” means **Paymaster (Jamaica) Limited**, a company registered under the laws of Jamaica with the registered offices at 9 Molynes Road, Kingston 10, Jamaica. References to “we”, “our” and “us” in these Terms also includes our subsidiaries and affiliates (“Affiliates”) from time to time.

“I” or “You” means the person participating in the Promotion (and “my” and “your” shall have the same meaning).

By participating in the Promotion, you agree to be bound by these Terms.

1. What is Likkle Extra Brawta from Paymaster?

This promotion will offer Paymaster customers who pay a minimum of eight (8) bills throughout the promotional period via Paymaster in store or online, one (1) entry into this promotion. Paymaster customers who participate in this promotion will stand a chance to be one of three (3) winners of a JMD\$100,000.00 cash prize.

2. What is the promotional period for this promotion?

The promotion is valid for the period Monday, January 23, 2023, 00:01 through to Tuesday, February 28, 2023, 23:59 (“the Promotional Period”). Paymaster reserves the right to change the Promotional Period at any time upon consultation and approval of the Betting, Gaming and Lotteries Commission and will notify customers of such change.

3. Who is eligible to enter the promotion?

To be eligible for the Promotion, you must be an existing or new Paymaster customer that conducts a qualifying activity (as defined in clause 4) during the Promotional Period.

The following customers are excluded from participating in the Promotion:

- a. Employees/families of employees of Paymaster (i.e., immediate family members e.g., Father, Mother, Sister, Brother) and employees of affiliates (Digicel) associated with this promotion.

4. How does a customer participate in this promotion?



- a. Customer must pay a minimum of eight (8) bills each at Paymaster during the promotional period, from the list of eligible billers, during the promotional period.
 - b. If a customer pays a minimum of eight (8) bills from the list of the eligible billers during the promotional period, they gain one (1) entry into the promotion.
 - c. Customers must provide their contact information (name and telephone number) at the Paymaster location where the bill is being paid to enter or via the online platform when registering.

5. **Which entities are the eligible billers for the purposes of this promotion?**
 - a. All the billers that are supported by Paymaster's Bill Payment services as specified (see appendix).

6. **Which Paymaster locations are participating in this promotion?**
 - a. All Paymaster locations across Jamaica. (See appendix)

7. **How will the Customer be notified if they have gained an entry into the promotion?**

The customers will be notified via SMS once they have paid a minimum of eight (8) bills. Sample SMS below:

"Congrats! You've qualified for "Likkle Extra Brawta from Paymaster" promotion. Be 1 of 3 winners of JMD\$100K cash. Promo ends Feb 28, 2023."

8. **How will the Customer be able to query the entry into the promotion?**

Customers will be able to query their status by contacting customer support center at 876-960-9632-5.

9. **How are the winners selected?**
 - a. A winner will be selected at random from the complete listing of eligible customers received during the Promotional Period.
 - b. The data generated will be exported to excel and the query will select three (3) winners from the list of entries

10. When will the prize draw be conducted?

There will be one prize draw to select the winners from the promotion at the Paymaster HQ on 9 Molynes Road, Kingston 10, Jamaica on Friday March 3rd, 2023, at 10:00 am.

11. How will winners be notified?

When selected, the winner(s) will be contacted by a Paymaster representative, calling the mobile phone number used by the selected customers to participate in the promotion. Attempts will be made to contact the winner(s) twice daily for a period of four (4) business days from the date of the prize draw specified in the table above. However, if the Paymaster representative fails to contact the winner within this time another winner will be randomly selected.

12. How will the prizes be allocated?

The three (3) winners will be awarded a cash prize of JMD\$100,000.00 each, payable via a Cheque or via a MyCash wallet.

13. What does the selected winners need to claim their prize?

During the telephone contact of the selected winners, full details of the winning prize will be communicated, they will be advised of the process and location for pickup will be confirmed. The winners will need to present a valid Government-issued photo ID (passport, voter's identification card or driver's license). The winner will be required to complete a Digital Redemption Form to be emailed customerrelations@paymaster-online.com confirming the receipt of their prize and/or a Consent and Release Form authorizing the use of their name and picture for marketing purposes as per the additional Terms and Conditions.

We reserve the right to disqualify you or terminate (upon consultation and approval of the Betting, Gaming and Lotteries Commission) this offer if, in our opinion, the Promotion is being abused, such abuse to include but not be limited to selling or attempts to sell the prizes, whether on a commercial basis or otherwise, general abuse deemed as an attempt to undermine the integrity of our services.
- C. To participate in this promotion customers are required to pay bills at any Paymaster location in Jamaica.

Any personal data relating to participants will be used solely for the purposes of this promotion by Paymaster and/or by any agent appointed by it to assist with running the promotion on behalf of the Paymaster and will not be disclosed to a third party for any other purpose without the individual's prior consent.
- H. By entering this Promotion, you consent to the use of your personal data by Paymaster and/or any agent appointed by it to assist with running the promotion for the purposes of administration of the promotion (including publishing your full name and parish and/or disclosing it to third parties on request if you are the winner) and any other purposes to which you have consented.
